*Map between Manufacturer IDs and Genes Alias*

---

## Description

gahgu95av2ALIAS is an R object that maps manufacturer identifiers to the corresponding gene alias.

## Details

Each manufacturer identifier maps to a vector containing the gene alias. If the gene alias is unknown, the vector will contain an NA.

Mappings were based on data provided by: Genecards ( <http://www.genecards.org> ) on 2010-Nov22

gahgu95av2ALIAS2PROBE *Map between Common Gene Symbol Identifiers and probeset Identifiers*

---

### Description

gahgu95av2ALIAS is an R object that provides mappings between common gene symbol identifiers and probeset identifiers.

### Details

Each gene symbol is mapped to a vector of probeset identifiers. The vector contains all probeset identifiers that are found for that symbol. An NA is reported for any gene symbol that cannot be mapped to any probeset identifiers.

This mapping includes ALL gene symbols including those which are already listed in the SYMBOL map. The SYMBOL map is meant to only list official gene symbols, while the ALIAS maps are meant to store all used symbols.

---

### Description

Welcome to the gahgu95av2.db annotation Package. The purpose of this package is to provide detailed information about the gahgu95av2 platform.

You can learn what objects this package supports with the following command:

gahgu95av2CHR

*Map probeset IDs to Chromosomes*

---

### Description

gahgu95av2CHR is an R object that provides mappings between a probeset identifier and the chromosome that contains the gene of interest.

### Details

Each probeset identifier maps to a vector of chromosomes. If the chromosomal location is unknown, the vector will contain an NA.

Mappings were based on data provided by: Genecards ( <http://www.genecards.org> ) on 2010-Nov22

### Examples

gahgu95av2CHRLOC

*Map probeset IDs to Chromosomal Location*

---

### Description

gahgu95av2CHRLOC is an R object that maps probeset identifiers to the starting position of the gene. The position of a gene is measured as the number of base pairs.

The CHRLOCEND mapping is the same as the CHRLOC mapping except that it specifies the ending base of a gene instead of the start.

### Details

Each probeset identifier maps to a named vector of chromosomal locations, where the name indicates the chromosome. If the chromosomal location is unknown, the vector will contain an NA.

Chromosomal locations on both the sense and antisense strands are measured as the number of base pairs from the p (5' end of the sense strand) to q (3' end of the sense strand) arms.

*Map between probeset IDs and gene descriptions*

---

**Description**

gahgu95av2DESCRIPTIONS is an R object that maps probeset identifiers to the corresponding gene name.

**Details**

Each probeset identifier maps to a named vector containing the gene descriptions. The vector name corresponds to the source of each description. If the gene name is unknown, the vector will contain an NA.

Mappings were based on data provided by: Genecards ( <http://www.genecards.org> ) on 2010-Nov22

**Examples**

gahgu95av2ENTREZID *Map between probeset Identifiers and Entrez Gene*

---

### Description

gahgu95av2ENTREZID is an R object that provides mappings between probeset identifiers and Entrez Gene identifiers. gahgu95av2ENTREZID2PROBE provides the reverse mapping.

### Details

Each probeset identifier is mapped to a vector of Entrez Gene identifiers. An NA is assigned to those probeset identifiers that can not be mapped to an Entrez Gene identifier at this time.

---

gahgu95av2GO

*Map between probset IDs and Gene Ontology (GO)*

---

## Description

gahgu95av2GO is an R object that provides mappings between probesets and the GO identifiers that they are directly associated with.

## Details

Each probeset identifier is mapped to a list of lists. The names on the outer list are GO identifiers. Each inner list consists of three named elements: GOID, Ontology, and Evidence.

The GOID element matches the GO identifier named in the outer list and is included for convenience when processing the data using 'lapply'.

The Ontology element indicates which of the three Gene Ontology categories this identifier belongs to. The categories are biological process (BP), cellular component (CC), and molecular function (MF).

The Evidence element contains a code indicating what kind of evidence supports the association of the GO identifier to the Entrez Gene id. The evidence codes in use include:

IMP: inferred from mutant phenotype

IGI: inferred from genetic interaction

IPI: inferred from physical interaction

ISS: inferred from sequence similarity

IDA: inferred from direct assay

IEP: inferred from expression pattern

IEA: inferred from electronic annotation

TAS: traceable author statement

NAS: non-traceable author statement

ND: no biological data available

IC: inferred by curator

NAs are assigned to probe identifiers that can not be mapped to any Gene Ontology information. Mappings between Gene Ontology identifiers and Gene Ontology terms and other information are available in a separate data package named GO.

gahgu95av2GO2PROBE      *Map between Gene Ontology (GO) and probesets*

---

## Description

gahgu95av2GO2PROBE is an R object that provides mappings between GO identifiers and probesets.

## Details

Each GO term maps to a named vector of probesets. The name associated with each probeset corresponds to the evidence code for that GO identifier. The evidence code indicates what kind of evidence supports the association between the GO and Entrez Gene identifiers. Evidence codes currently in use include:

IMP - inferred from mutant phenotype

IGI - inferred from genetic interaction

IPI - inferred from physical interaction

ISS - inferred from sequence similarity

IDA - inferred from direct assay

IEP - inferred from expression pattern

IEA - inferred from electronic annotation

TAS - traceable author statement

NAS - non-traceable author statement

ND - no biological data available

IC - inferred by curator

A GO identifier may be mapped to the same probe identifier more than once but the evidence code can be different. Mappings between Gene Ontology identifiers and Gene Ontology terms and other information are available in a separate data package named GO.

## Details

Each manufacturer identifier maps to a named vector containing the Interpro domain. The vector name corresponds to the Interpro IDs. If the Interpro domain is unknown, the vector will contain an NA.

gahgu95av2MAPCOUNTS    *Number of mapped keys for the maps in package gahgu95av2.db*

---

### Description

gahgu95av2MAPCOUNTS provides the "map count" (i.e. the count of mapped keys) for each map in package gahgu95av2.db.

### Details

This "map count" information is precalculated and stored in the package annotation DB. This allows some quality control and is used by the [checkMAPCOUNTS](#) function defined in AnnotationDbi to compare and validate different methods (like `count.mappedkeys(x)` or `sum(!is.na(as.list(x)))`) for getting the "map count" of a given map.

gahgu95av2ORGANISM    *The Organism for gahgu95av2*

---

### Description

gahgu95av2ORGANISM is an R object that contains a single item: a character string that names the organism for which gahgu95av2 was built.

### Details

Although the package name is suggestive of the organism for which it was built, gahgu95av2ORGANISM provides a simple way to programmatically extract the organism name.

### Examples

gahgu95av2SWISSPROTID *Map between probesets and Genes*

---

### Description

gahgu95av2SWISSPROTID is an R object that maps probe identifiers to the corresponding swissprot id.

### Details

Each probeset maps to a vector containing the swissprot id. If the swissprot id is unknown, the vector will contain an NA.

Mappings were based on data provided by: Genecards ( <http://www.genecards.org> ) on 2010-Nov22

### Examples

gahgu95av2SYMBOL *Map between probeset and Gene Symbols*

---

### Description

gahgu95av2SYMBOL is an R object that provides mappings between probeset and gene abbreviations. gahgu95av2SYMBOL2PROBE provides the reverse mapping.

### Details

Each probeset is mapped to an abbreviation for the corresponding gene. An NA is reported if there is no known abbreviation for a given gene.

Symbols typically consist of 3 letters that define either a single gene (ABC) or multiple genes (ABC1, ABC2, ABC3). Gene symbols can be used as key words to query public databases such as Entrez Gene.

## Description

gahgu95av2UNIPROT is an R object that contains mappings between probeset identifiers and Uniprot accession numbers.

## Details

This object is a simple mapping of custom probeset identifiers to Uniprot Accessions.

### Description

Some convenience functions for getting a connection object to (or collecting information about) the package annotation DB.

### Usage

gahgu95av2_dbInfo()
```

### Arguments

file	A connection, or a character string naming the file to print to (see the file argument of the <a href="#">cat</a> function for the details).
show.indices	The CREATE INDEX statements are not shown by default. Use show.indices=TRUE to get them.

### Details

gahgu95av2\_dbconn returns a connection object to the package annotation DB. **IMPORTANT:** Don't call [dbDisconnect](#) on the connection object returned by gahgu95av2\_dbconn or you will break all the [AnnDbObj](#) objects defined in this package!

gahgu95av2\_dbfile returns the path (character string) to the package annotation DB (this is an SQLite file).

gahgu95av2\_dbschema prints the schema definition of the package annotation DB.

gahgu95av2\_dbInfo prints other information about the package annotation DB.

### Value

gahgu95av2\_dbconn: a DBIConnection object representing an open connection to the package annotation DB.

gahgu95av2\_dbfile: a character string with the path to the package annotation DB.

gahgu95av2\_dbschema: none (invisible NULL).

gahgu95av2\_dbInfo: none (invisible NULL).
